RE: FIPPA Access Request #17-210

I am responding to your request received November 17, 2017, under the Freedom of Information and Protection of Privacy Act (FIPPA), for:

- e) The number of claims with NEL awards (by initial NEL award year) where the worker has entitlement for chronic pain disability;
- f) The average PI% for each claim with NEL awards (by initial NEL award year) where the worker has entitlement for psychotraumatic disability:
- g) The average PI% for each claim with NEL wards (by initial NEL award year) where the worker has entitlement for traumatic mental stress; and
- h) The average PI% for each claim with NEL awards (by initial NEL award year) where the worker has entitlement for chronic pain disability.

# Items 1-2: Non-Economic Loss (NEL) and Traumatic Mental Stress Data:

Item 1 a,b,d,g and Item 2 a,b,c:

Access is granted. Please find a copy of your record enclosed herein.

## Item 1 c,e,f,h:

The record you are requesting does not exist. I have been informed by the Corporate Business Information & Analytics branch that this information is not specifically tracked. When a claim is allowed for more than one condition, the data does not differentiate the area of injury.

Items 3-4: Psychotraumatic Secondary Entitlement and Chronic Pain Disability (CPD) Data: As indicated to you in a letter by Ashleigh Burnet on May 29, 2014, under FIPPA Access Request #14-017, the Psych/CPD Speciality Program was formed in May 2012 to decide cases where such conditions arose secondary to the work-related injury or from a condition resulting from a work-related injury. When a WSIB claim is initiated, our system captures the initial area of injury for statistical coding purposes; any secondary conditions are counted manually by decision-makers. Therefore, since Psych/CPD are secondary conditions, the data provided in the below table (May 2012 to November 2017) has been manually gathered and, as such, may not be entirely accurate.

#### \*Data Definitions/Notations:

- NEL awards include claims with a non-economic loss (NEL) benefit for a work-related permanent impairment (PI) awarded between 2009 and 2016.
- · Award year is based on the date of the first NEL award.
- The average PI percentage is based on the total NEL PI percentage awarded in each claim.
- · Excludes claims assessed with 0% permanent impairment.
- Traumatic mental stress (TMS) claims includes allowed and denied claims registered between 2009 and 2016.
- A lost time claim is created when a worker suffers a work-related injury/disease which results in: being off work past the day of accident, loss of wages/earnings, or a permanent disability/impairment.
- A no lost time claim results from a work-related injury where no time is lost from work, other than on the day of accident, but where health care is required. The health care costs resulting from the injury are paid by the WSIB.
- Denied claims are claims determined to be non-work related, or claims by workers who were not covered under the Workplace Safety and Insurance Act (WSIA).
- · Denied TMS claims include both lost time and no lost time claims.
- Please note data is subject to further maturing. Data continues to be revised after the year has concluded as additional claims are reported and decisions on complex claims are made.
- Non-economic loss cannot be assessed until a worker has reached maximum medical recovery (MMR). As such NEL awards are typically awarded within 3 years of incident.
